Of the Municipal Corporation of the Township of Tiny to license, regulate and govern motor vehicles racing in the Corporation of the Township of Tiny.

WHEREAS it is deemed advisable to provide for the licensing, regulating and governing of the racing of motor vehicles and the holding of motor vehicle races.

NOW THEREFORE the Municipal Council of the Township of Tiny enacts as follows:

1. As used in this By-law -

- (a) "Motor Vehicle" means any automobile, motorcycle or any other vehicle propelled or driven otherwise than by muscular power.
- (b) "Resident" means the occupant and owner or where it is vacant, the owner of any structure or building used or capable of being used as a dwelling house by one or more persons or families.
- (c) "Place of Business" means any structure or building used or capable of being used as a place wherein business of any type may be carried on.
- (d) "Person" means any individual, firm, trust, partnership, association or corporation.
- 2. Racing of motor vehicles or the holding of motor vehicle races within the limits of the Corporation of the Township of Tiny shall be unlawful unless a license shall have been first obtained therefore.
- 3. Applications for a license to race motor vehicles or to hold motor vehicle races shall be filed with the By-law Enforcement Officer and a license therefore shall be issued by the By-law Enforcement Officer on the order of the Municipal Council.

  Applications signed by the applicant shall contain the following:
  - (a) The name, address and occupation of the applicant.
  - (b) The location, full legal description and particulars of ownership and occupancy of the place wherein racing is to be held.
  - (c) A complete plan of the property whereon the racing is to be held and showing thereon the location and particulars of ownership and occupancy of all buildings and structures lying or being in whole or in part within five hundred feet (500') in a straight line of the property whereon the racing is to be held.
  - (d) The consents of the residents dwelling within five hundred feet (500') of the property whereon the racing is to be held.
  - (e) The consents of the operators or if none the owners of every place of business lying within five hundred feet (500') of the property whereon the racing is to be held.
- 4. The application and all accompanying material shall be filed in duplicate.
- No license shall be issued unless and until there is recorded upon the

application or attached to it the report of the By-law Enforcement Officer that the applicant is of good moral character.

- 6. Each application for a license to race motor vehicles or for the holding of motor vehicle races shall be accompanied by a licensing fee by way of certified cheque in the amount of One Hundred Dollars (\$100.00) and each license is valid for one event only and must be renewed for each additional event.
- 7.

  Any Municipal Organization under the direction of the Township of Tiny

  Parks and Recreation Centre Board are exempted from this By-law.
- Every person who contravenes any of the provisions of this By-law shall, upon conviction thereof, forfeit and pay at the discretion of the convicting Magistrate a penalty not exceeding the sum of Three Hundred Dollars (\$300.00) for each offence.
- 9. This By-law shall come into force and take effect immediately after the final passing thereof.

By-law read a first, second and third time and finally passed this 3/2 day of farming 1974.
